- One Auto Debit bank rejection results in a \$35 late fee
- A second bank rejection results in suspension of Auto Debit privilege and the account must be paid one month in advance by cashier check thereafter, (monitored

- If the account remains delinquent, the matter is referred to the Principal
 - If the account continues to remain delinquent, it is referred to the Parish Collection Committee.
 - Students with delinquent accounts will not be allowed to re-register for the following school year.
 - Students may be denied enrollment if tuition accounts are not kept current.
3. If any sum due under this contract is placed in the hands of an attorney or collection agency for collection, I promise and agree to pay St. Patrick School reasonable attorney's fees and collection costs, whether or not the suit or action is filed.
 4. To qualify for the Participatory Rate of tuition, I agree to perform 30 hours of service to the school. Service hours can be bought out at the rate of \$20/hour.
 5. Failure to perform service hours will result in a higher Non-Participatory rate of tuition the following school year.
 6. I expressly authorize St. Patrick School to release my tuition account along with other necessary records (e.g. transcript) requested by any public and/or private school, local credit bureau, collection agency or any school official, employee or agent who has a legitimate educational or legal interest in the information.
 7. The following will apply to Eighth grade tuition accounts:
 - All outstanding balances must be paid prior to entrance to Eighth Grade
 - All tuition for any student in 8th grade must be paid in full by **April 1st** of the 8th Grade year.
 - All 8th Grade fees must be paid in full by **April 1st** of the 8th Grade year
 8. I understand that all policies, terms and conditions, as set forth in the St. Patrick Parent-Student Handbook to the extent that they are in accord with Archdiocesan policy and procedures are incorporated by reference and made a part of this agreement.
